International Conversion Information Sheet

All three are required for conversion for international pilots. FAA pilots write a separate FAA conversion exam but covering similar content.

- ATPL, SAMRA, SARON and IFR Ground Schools are offered regularly. Some pilots, given time and location issues, choose to just attend just the more complex ATPL (SAMRA/SARON course) and self-study for the INRAT using the IFR workbook and Online IFR Procedures course.
- The 4–6-hour Online IFR Procedures module is very helpful to become familiar with the Canadian Approach Plates and Canadian Air Regulations.

- A conversion pilot must be registered with Transport Canada to book at timeslot to write the Transport Canada exams.
- Transport Canada administers all the exams at their centres, and you must make all the arrangements with them to convert your license and register to write the exams.
- International conversion pilots will also need to satisfy other criteria (a medical and flight tests) which are not services offered by AeroCourse.
- Flight tests are conducted by flight schools or other training facilities who offer that service directly.
